institution doesn't have a separate budget head allocated for library, the purchase of required books and journals for library is done from office/ administrative budget/expenses. Administrative officer also mentioned that as of now the institution has a balance of 45,000/- Rs from grants and institution will receive additional grant in month of January 2020 afterwhich an amount of Rs. 15 lakhs can be alloca ted for library related purchase.

Dean sir took an update from the members of committee about the work done towards the purchase of books and journals for financial year 2019-20. The Librarian informed that all the department heads have been informed to provide a priority wise list of books and journals to library for procurement by 22nd November, 2019.

It was also discussed that as per the letter received by Mantralaya (सा प क वैशिवि-२०१७/प्र.फ्रं.३१३-भाग-२/प्रसा २ मंत्रालय मुंबई-१ दिनांक ८ नोव्हेंबर २०१७) a Library committee has been formed at the institution level and the work of the Chairperson, Professors of all departments who are members of the library committee will be restricted to recommendation and selection of books and journals as per the medical council and dental council of India. It was discussed and informed that the librarian will hold the post of Secretary, library committee and will be responsible for purchase of books and journals, procuring them from dealers, and will follow up with the pending purchase process of books and journals.

Administrative officer will also be a member of the library committee. He will be responsible for purchase of books and journals with will look into the terms and conditions of the annual budget/grants. The purchase will be done within the sanctioned amount and no extra purchase will be made.

 Objection of Lekha Padtalani Vibhag, Matters pertaining to handing over of responsibilities of librarian and other 2 class IV staff were discussed as there will be limited manpower available due to promotion or retirement.

Librarian informed the committee members that the *Lekha Padatalani Vibhag* has raised objection to the fact that the books and the journals are not verified physically from 2010 to 2017. He also stated that the concerned work is not completed and the scrutiny is still

going on at Dean and Directorate level and the report will be submitted to Lekha Padatalani Vibhag once the work is done. The abovesaid has been communicated to the Lekha Padtalini Vibhag by the Librarian.

It was discussed and the librarian was requested that the work of physical verification of the books and journals should be started as early as possible. The Librarian commented that due to deficiency of class 3 staff (post vacant) since last two years and 2 posts of class 4 will be vacant from March 2020 is not possible for single librarian to physically verify and prepare a computerized documentation of the same. A request for more manpower allocation to the library was made.

3) A committee comprising of Dr. Jyoti Tembhurne; Professor and Head Department of Prosthodontics GDCH, Mumbai, Dr. Suryakant Powar, Associate Professor and Head, Department of Orthodontics, Dr. Rajesh Gaikwad; Department of Periodontics was formed to look into the matter of infestation of books and journals by termites. The committee was asked to submit a detailed report regarding the extent and seriousness of the issue. No report was documented by the committee. Dr Jyoti Tembhurne, Professor and Head Department of Prosthodontics requested Dean sir to remove her name from the committee and so Dr. Prajwalit Kende was included in the same committee with agreement between all the members.

Dean sir thanked all the committee members and the meeting was concluded.
